B. RLC Goals & Purpose Gunderman 20 minutes

This item is to outline the Region Leaders Council term goals.

- Chair Kaleem: RLC has the capability to connect all 10 Region Leaders.
- Region IV: RLC was created by Kevin Filiciano, previous SSCCC President & Region IV Chair; it was meant to mentor & help region leaders run their meetings efficiently. Would like RLC to focus more on EA work within regions and suggests we send letters of support to locall legislators
- Region III: There are efforts to create advocacy committees within regions, so RLC can focus on strengthening that
- Region V: Have Regional Chairs keep more in touch
- Region II: Preamble states that we are here to connect & strengthen regions. Mission statement needs to be drafted for RLC Constitution. Most ASOs aren't aware of SSCCC, so region leaders need to educate constituency. At Lake Tahoe, relationship between students, senate, and advisor was healthy, but not many students knew about regions. We should work on a grassroots level
- Region VII: Would like to unify colleges, & reform Prop 13, extend Prop 30
- Region X: Really would like to engage students, let students know how to access resources
- Region VI: Establish \$2 SRF, increase Regional & SSCCC awareness, institutional memory for RLC, Resolution implementation
- Region II: SSCCC is trying to be incorporated as a 501(c)3, but people were unaware that it passed through brown act bodies. At next GA, we will have constitutional conventions, so RLC can disseminate constitution to regions for constructive feedback.
- Nehasi Lee: Was a senator in 2010-2011, EA committee did not exist at the time. Post resolution from 2011 on RLC website.

- Chair Salem, Region IV: Attended Southern Retreat, started at 10 am, highlights were Parli Pro & Legislative Affairs Update workshops. It was a 3 day retreat, tarted kind of late in the day, everyone was able to attend workshops since there was only one workshop at a time. San Diego had a lot of food options nearby.
- Nehasi Lee: How many people?
 - Chair Salem: 60 people, Regions IX, V, & VII were present; region officers/execs/college delegations
- Chair Salem: If anyone would like to have tips on retreats, contact Senator Sirotnak/Chair Kaleem. Tips would be to let ASOs be responsible for paying for their students, with regional account as back up. Lorenzo Cuesta will come for free to any region for Parli Pro workshop, only need to pay for transportation.
- Region III: Did not meet quorum at regional meeting, & will be having a meeting on Saturday to talk about retreat details.

- Chair Kaleem: RLC website needs to be updated with all regional websites, & encourages region leaders to have updated websites. Will be in contact with Region Leaders to get websites.
