- **H. September Legislative Update** D/A Kaleem/Galeana 20 Minutes *The Region Leaders Council shall hear an update on recent legislation and possibly take action on certain bills.*
 - AB 798 Bonilla Textbook Affordability Act of 2015 Instate a database and funding source to maintain and populate such a database with open

source education materials; including textbooks, course programs, notes, study materials, and more.

- AB 288 Holden Expanding enrollment opportunities. Grant program to institute similar programs to the Shasta College Promise Program.
- AB 1461 Voter Registration Would register voters through the DMV license database. allowing citizens the option to opt out of registration. This bill was put into place due to the significant lack of voter registration the state faces. Will save state money by avoiding the production of voter registration documentation that will not longer be needed.
- AB 25 Gibson Requires the California Student Aid Commission (CSAC) to establish an appeals process for an otherwise qualifying institution that fails to satisfy the 3 year Cohort Default Rate and Graduation Rate requirements.
- Legislative visits Build your team, train up team members, reinforce each member's confidence in what they are talking about and help them understand why it is important and valuable. Find key places where students have made changes in the legislative process. Refine testimonial and topic points.
